
WHAT IS THE TIMELINE OF THE UNFUNDED LIABILITY?



HOW LONG WAS RETURN TO WORK TAKING IN 2020?

While the pandemic was a factor, we are seeing increasingly complex claims where there are often psychological considerations to physical injuries. Claims lasted an average of **178 days**, or nearly six months.

HOW MANY NOVA SCOTIANS WERE HURT AT WORK?

There were 4,977 **TIME-LOSS CLAIMS IN 2020**. While this is progress over 2019 when there were 5,663 Nova Scotians hurt in the workplace, some is due to changes in the workforce due to COVID-19.



The total number of registered claims in 2020 was **19,994**, a 20 per cent decrease from 24,900 in 2019.

WHAT WAS THE INJURY RATE?

There were 1.53 time-loss injuries per 100 covered workers in 2020, a decline from 1.67 in 2019.

WHAT TYPE OF INJURIES OCCURRED?

MUSCULOSKELETAL INJURIES

(sprains, strains, and other soft-tissue injuries) continue to make up the highest percentage of time-loss injuries.

In 2020, they represented 63% of all time-loss injuries.

of all time-loss injuries were to the back, which continues to be the most frequently injured part of the body. HOW MANY NOVA SCOTIANS HAD PSYCHOLOGICAL WORKPLACE INJURIES IN 2020?

There was a **slight decrease in psychological injury claims in 2020**, the second full year WCB operated with presumptive PTSD legislation for front line and emergency response workers.


The five largest industries, measured by assessable payroll, showed improvements in injury frequency rate per 100 covered employees compared to 2019.
