This role provides leadership, innovation and consultative services to organizations to promote and evaluate effective OH&S and Return-to-Work activities and have a direct impact on the development and promotion of best practice models. Establishing positive relationships across all levels, this role will conduct organizational assessments to evaluate the effectiveness of health and safety and return-to-work programs, initiatives and policies.

Through the delivery of high impact consulting, the Workplace Consultant will coach workplaces to set and achieve attainable, meaningful, measurable and sustainable goals to reduce injury frequency, the duration of injures and the associated costs of these injuries.

The Workplace Consultant will be responsible for the following:

- Provide leadership, innovation, advisory and consultative services to assigned workplaces to promote and evaluate effective and efficient occupational health and safety activities in the workplace.
- Establish, maintain and promote effective relationships within workplaces working with all levels; including but not limited to, senior executives, managers, and front-line personnel
- Must understand the WCB organizational structure, services, and processes to coach customers
  to prevent workplace injuries and the promotion of early and safe return to work for injured
  workers, as a member of a cross function team
- Coach workplaces to develop a framework to conduct workplace health and safety assessments, developing health and safety technical literature, departmental policy and procedures, guidelines and certification standards, and return-to-work programs.



The Workplace Consultant may require extensive travel, working with selected workplaces
individually and/or in a group setting across the province. The Workplace Consultant through
the course of their employment may be exposed to many workplace elements that are
considered high-risk.

- A University degree in the sciences or business, preferably with major course work in health and safety management and a combination of both the knowledge/skills required and practical experience.
- Demonstrated understanding of organizational behavior and organizational structure to enable coaching of employer working teams to meet desired outcomes.
- Experience in structured team building and oral/written communication skills are key components of this position.
- A CRSP designation would be a definite asset as would experience in Return-to-work program design.
- Experience representing an organization and working with key stakeholder groups such as government, business, organized labour, and worker representatives is an asset
