Highlights of the meeting of the Board of Directors of the Workers Compensation Board of Nova Scotia.

At its meeting on March 27th 2025, the Workers' Compensation Board of Directors:

- Approved the report of the Finance, Audit and Risk Committee on discussions at the March 20, and March 24, 2025 meetings of the Committee including:
 - An overview of the highlights of the preliminary 2024 year-end financial results and statistical information for inclusion in the 2024 Annual Report;

 - A year-end evaluation of the custodian services for the WCB Nova Scotia.

- Received the WCB Occupational Health and Safety Report for the quarter ended December 31, 2024.
- Received an update on the 2025 Operational Plan.
