At its meeting of May 21-22nd 2015 the Workers' Compensation Board of Directors:

- Welcomed new members Duncan Williams and Jeff Brett to the Board of Directors.
- Received and approved a report from the Chair of the Finance, Audit and Risk Committee on discussions at the May 21st meeting of the Committee:
 - The Committee met the Internal Auditor to receive an update on the status of ongoing work underway in 2015. The Committee also received an overview from the Internal Auditor of revised scope and fees to provide risk advisory assistance for the Business Transformation Advancement Program in 2015.
 - The Committee received an overview of the proposed 2016 budget and plan for the Business Transformation Advancement Program. The Committee also received an overview of the Business Cases associated with initiatives planned in 2016 for the Business Transformation Advancement Program.
