## WORKPLACE TRAGEDIES UNDERLINE IMPORTANCE OF SAFETY AWARENESS

Acute workplace fatalities increase over last year

Increasing workplace fatalities in Nova Scotia in 2018 underscore the need for continued safety awareness.

There were 18 deaths in the first two quarters of the year, compared to nine in Q1 and Q2 2017. Half of those deaths were acute fatalities, where a traumatic incident at work led to fatal injury. That's more than four times the number of acute deaths in the first half of 2017.

Early May – around the time of NAOSH Week – was particularly tragic, with five deaths at work occurring within a week.

"Too many people continue to die at work or because of their work in Nova Scotia," says WCB Nova Scotia CEO Stuart MacLean. "These stories of human tragedy that punctuate the overall story of workplace safety in our province are stark reminders that our work is never done." The range of tragedies so far in 2018 includes motor vehicle crashes, falls, and vessels capsized or workers going overboard in the fishing sector.

The number of acute fatalities fluctuates from year to year, but 2018 is trending to be an above average year.

"No one should die as a result of their work, and every workplace fatality is a tragedy. The increase in 2018 speaks to the need for continued work by all of us to keep Nova Scotians safe on the job," MacLean says.

The human tragedies are a grim undertone to an overall safety culture story that seems to be continuing its slow improvement in our province. As of the midpoint of 2018, the time-loss injury rate had declined from 1.76 at the end of 2017 to 1.73 time-loss injuries per 100 covered workers.

Service surveys continue to suggest both workers and employers are pleased with the service we provide, and our financial results are strong.

But for those claims that do result in time loss, there are still significant challenges when it comes to achieving return to work. Claims are taking longer to resolve, impacting our measures in this area – Time Loss Days Paid per 100 Covered Employees and the Composite Duration Index, which increased to 121 days.

The increase is due to a combination of factors. The WCB's ongoing modernization has meant workforce transitions, which has come with some operational impact.

Challenges in certain industries also continue to pose opportunity. As just one example, more than 70 per cent of the increase in the total number of days lost to workplace injury between 2013 and 2018 came from the Health and Social Services industry group, with the greatest increases in long-term care and home care.

Recognizing the challenge, the industry and stakeholders have responded, recently announcing a plan that's the product of two years of work to identify a path for improvement. Work is now underway to support the implementation of the 21 recommendations to improve safety outcomes in these sectors in *Charting the Course: Workplace Safety for Nova Scotia's Home Care, Long term Care & Disability Support Sectors.* **Q2**

### New video shows impact of workplace safety in health care

The AWARE-NS's annual general meeting at the end of June marked the launch of the Charting the Course report and a video that tells the compelling human story of why workplace safety in home care, long-term care and disability support sectors is important. In 2017, 1,694 Nova Scotians in the health care sector lost time from work due to injury on the job. The video is a reminder that behind every time-loss statistic is a person who was hurt at work, and a life that was thrown out of balance. ### WCB Nova Scotia releases 2019 employer assessment rates

WCB Nova Scotia employer assessment rates will remain stable for the 15th straight year at an average of \$2.65 per \$100 of payroll in 2019. Fifty-six per cent of Nova Scotia employers will pay the same or less in 2019 than they are paying this year, while 44 per cent will see an increase.

Employers with claims costs significantly and consistently higher than their industry peers – 96 in 2019 – will face a surcharge over and above their normal assessment rate.

#### New campaign focuses on impact of workplace injuries at home



Over the summer, WCB Nova Scotia, in partnership with the four Atlantic Workplace Compensation Boards and the Nova Scotia Department of Labour and Advanced Education, began filming ads for a new awareness campaign. The campaign is centred around three families whose lives have been changed by workplace injury, occupational disease and a fatality. It is a call for Nova Scotians

to consider the consequences of unsafe work practices and all those who are affected as a result. The ads will begin airing later this fall.



### **STANS recognized for safety achievements**

Through intensive training and collaboration, the Society for Treatment of Autism Nova Scotia (STANS) has completely changed their approach to safety in the workplace. Like many organizations in the health care sector, STANS faced difficult working conditions, with their 100 employees navigating high-risk situations on a daily basis. With guidance from WCB Nova Scotia and AWARE-NS, STANS began engaging in education sessions, workplace consulting and coaching, JOHSC training and more. They developed a formal return-to-work program and a process to review safety practices regularly, and have seen a significant reduction in their claim volume and costs as a result. In recognition of these efforts, they were awarded a WCB Workplace Recognition Award in June 2018.
