

## **WCB Rates: Surcharge List – 2016**

*Each year the WCB issues surcharges to employers whose claims costs are significantly and consistently higher than their industry peers. The Surcharge Program is designed to encourage employers to make improvements to their safety and return to work programs. To be surcharged, an employer's claims cost experience must be at least three times their industry average, or 200 per cent higher, for at least four consecutive years. In 2016, 108 employers are receiving a surcharge.*
